Victims may be left without immediate help, exacerbating their injuries or even resulting in fatalities that could have been prevented with timely assistance. Legally, a hit-and-run is a serious criminal offense, with perpetrators facing severe penalties, including fines, imprisonment, and the loss of driving privileges. The emotional trauma for victims is significant, with many experiencing anxiety, depression, and post-traumatic stress disorder (PTSD). Additionally, the financial burden of medical bills, vehicle repairs, and lost wages can be overwhelming, especially if the perpetrator is not apprehended.
